<b>Referral Eligibility Criteria</b>	<ul style="list-style-type: none"> <li>• Eligible practitioners include:             <ul style="list-style-type: none"> <li>◦ Practitioners, Healthcare Companies/Systems that have active National Provider Identification (NPIs), EMR/PM/Apps that are contracted by NPI Holders, Billing and Marketing Companies contracted by NPI Holders.</li> </ul> </li> <li>• A successful referral is one where the referred has signed pVerify's Terms of Service, a BAA, and has paid their first invoice for services or setup fees.</li> <li>• Referral fees will be issued a Visa Gift Card based on referrals signed contract             <ul style="list-style-type: none"> <li>◦ 10% of the initial monthly subscription contract amount</li> <li>◦ Example: \$500 Monthly Subscription Plan = \$50 Visa Gift Card</li> <li>◦ Minimum Gift Card amount is \$25</li> </ul> </li> <li>• Any leads that are already part of the pVerify sales funnel (i.e. leads that exist in pVerify's ZOHO CRM before the referral is made) will not be eligible for this referral program.</li> </ul>
